### 4. First-aid measures

**Methods and materials for containment and cleaning up**

Refer to attached safety data sheets and/or instructions for use. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Keep combustibles (wood, paper, oil, etc.) away from spilled material. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Absorb in vermiculite, dry sand or earth and place into containers. Shovel the material into waste container. Following product recovery, flush area with water.


