- Reduced supply of some products
- Pricing volatility across the supply chain
- Production delays

HVAC Regulation Update

- As of January 1, 2024, the EPA has required a 40% reduction in the production of higher-GWP refrigerants including R-410A.
 - This is a phase down, not a phase out, R-410A refrigerant will still be available.

R-410A Equipment Available

We have substantial inventory of R-410A HVAC equipment available. This includes a wide range of units, offering reliable performance and energy efficiency to meet our customers' needs.

- For customers planning to transition to [A2L refrigerant](#) when that equipment becomes available, Chadwell Supply will carry Brothers (R-32), Goodman (R-32) and AirQuest (R-454B) compatible equipment.
- New A2L compatible equipment will either come with and/or require leak-sensing technology that is programmed to shut systems down if a leak is detected.

A2L Refrigerant Supply Challenges

The new A2L refrigerants—R-454B and R-32—are experiencing significant pricing volatility and product scarcity.

- Manufacturers report limited availability, extended lead times, and rising prices.
- Chadwell has implemented one per customer per day order restrictions on R-454B refrigerant. Similar restrictions may be placed on R-32 refrigerant.

Chadwell Supply has an abundance of R-410A refrigerant and equipment. Customers who are not ready to make the shift to A2L refrigerants have the option to stick with what they know for a limited time:

- Since January 1st, 2025, R-410A equipment cannot be manufactured or imported
- No more R-410A equipment will be made.
- All remaining R-410A equipment must be sold and installed by the end of 2025.

SHIPPING UPDATES

SUEZ CANAL—Representatives of the Suez Canal Authority reported that “security in the Red Sea is gradually improving.” The number of ships traversing the Suez Canal increased in Q1, the first positive sign since attacks on shipping vessels led global shipping giants to avoid that passage in favor of the longer route around Africa. Challenges still exist, but officials are hopeful that stability is returning to this vital maritime corridor.
